## Registration Policies:

### **Deadlines:**

The deadline for Registration is July 1<sup>st</sup>.

Registration Fees must be paid in full by September 1<sup>st</sup>.

### **Fees:**

A \$50.00 late fee will be added to all registrations received after July 1<sup>st</sup>.

All NSF or stopped payments will be subject to a \$25.00 administration fee.

### **Post Dated Cheques:**

Post dated cheques will be accepted for the following dates ONLY:

April 15 <sup>th</sup>	May 15 <sup>th</sup>	June 15 <sup>th</sup>	July 15 <sup>th</sup>	August 15 <sup>th</sup>
April 30 <sup>th</sup>	May 30 <sup>th</sup>	June 30 <sup>th</sup>	July 30 <sup>th</sup>	August 30 <sup>th</sup>

### **Refund Policy:**

A Parent or Guardian must complete a "Request for a Refund" form (found on our web site [www.stmha.net](http://www.stmha.net)) Upon approval, there is a 4 – 8 week processing period. There will be no refunds after November 30<sup>th</sup>. No refund will be issued until any equipment or property of St. Thomas Minor Hockey Association has been returned and satisfactorily accepted the St. Thomas Minor Hockey Association. The following refund rates will apply for refund request received on or before:

#### **House League:**

September 30<sup>th</sup> - 100%

October 31<sup>st</sup> – 75%

November 30<sup>th</sup> – 50%

#### **Travel:**

August 30<sup>th</sup> – 100%

September 30<sup>th</sup> – 75%

October 31 – 50%

All refunds are subject to a \$25.00 Administration Fee, which will be deducted from all refunds.

### **Players Trying out for AAA:**

All Players trying out for AAA teams must register with their home association before a "Permission to Skate" form can be issued. St. Thomas Minor Hockey will require a cheque for the General Registration Fee & Tryout Fee (\$460.00). This cheque may be post dated for September 15<sup>th</sup>. Upon notification of the player signing with a AAA team the cheque will be returned. If St. Thomas Minor Hockey is not notified of the players status with the AAA team prior to September 15<sup>th</sup> the cheque will be deposited. Players returning to St. Thomas Minor Hockey must provide payment of the registration fees as outlined above.

### **Consent and Release:**

Upon acceptance of this registration application, I consent that the player named on this application is able to participate in the hockey program of the St. Thomas Minor Hockey Association. I agree to abide by all regulations, rules, bylaws, policies and the Code of Conduct of the St. Thomas Minor Hockey Association.
